The NFPF is the nonprofit organization created by the U.S. Congress to help save America's film heritage. Working with archives, the NFPF preserves American films that are unlikely to survive without public support, improves film access for education and See Form 990, Page 2, Part III, Line 1 (continued)

Preserving American Films through grants. Saved 134 films through 58 new grants of cash and donated preservation services to archives, historical societies, libraries, museums, and universities. Among the new projects are Money at Work (1933), commissioned to bolster faith in small town banks during the Depression; Land of the Zuni (1923); In the Moonshine Country (1918); George Stoney's The Hudson Shad (1973), narrated by Pete Seeger; Our Union (1948); Growing Baby Beef in Montana (1933-34); Billy Woodberry's Bless Their Little Hearts (1984); Bristol, Tennessee, Newsboy Soapbox Derby (1955); Peanut Picking (1942), Blackie the Wonder Horse Swims the Golden Gate (1938) and other subjects that generally fall under the radar of the mainstream media. Films preserved by the NFPF are made available for education and shared with the public via screenings, exhibits, DVDs, broadcasts, and the Internet. The grants are awarded by expert panels, which are recruited from the preservation and scholarly communities and serve on behalf of the NFPF Board. The grants are open to American nonprofit and public institutions of all sizes and experience levels.

Promoting Film Preservation through Publications. The NFPF produces the award-winning Treasures DVD series presenting American films preserved by archival institutions and previously unavailable on video. Treasures films are contextualized for educational and home audiences with new music, commentary, and a printed catalog. The sets are used in libraries and universities around the world. In 2010, we ramped up production of Treasures 5: The West 1898-1938, exploring how the West was recorded and imagined in early film. The 40-film, 3-DVD anthology with book will be released in fall 2011. All the NFPF's DVD sets are kept in print. As with all NFPF publications, free copies will be given to state libraries and net proceeds go to support further film preservation. (DVD manufacturing expenses are reported on the 990, Part VIII, as Cost of Goods Sold). In addition we continued to distribute our award-winning Film Preservation Guide (2004), which can be downloaded free from our Web site or requested for a modest mailing fee. The internationally-acclaimed primer has been translated into 3 languages. Our Field Guide to Sponsored Films is also distributed through these channels.

Repatriating American Films Unavailable in the United States. We began a partnership with the New Zealand Film Archive to repatriate and preserve American silent films unavailable in the United States. In 2010 the NFPF funded two research trips to identify the films and assess their condition. The first 75 titles were returned in 2010, including John Ford's Upstream (1927); Maytime (1923) with Clara Bow; the first surviving film directed by and starring comedienne Mabel Normand; the earliest surviving narrative shot in Yosemite; and other rarities. Some 90% are thought to exist nowhere else. The American nitrate archives are supervising the presentation and will take custody of the nitrate originals, as well as the new preservation masters and prints. The NZFA will also receive prints. The NFPF, which is managing and funding the project, will make digital copies of many titles available on our Web site in the months ahead. This project is described in the NFPF 2010 Report to the U.S. Congress (which may be downloaded from the NFPF Web site) and expected to take several years to complete. The National Society of Film Critics saluted the rediscovery of Upstream with a 2010 Film Heritage Award, shared by the collaborating institutions.
