The NFPF is the nonprofit created by Congress to save America's film heritage. Working with archives, the NFPF preserves American films, improves access for education and exhibition, and encourages film as art, history, and cultural resource.

Preserving American films through grants. Saved 65 films through cash grants to 40 archives, historical societies, libraries, museums, and universities. Among the films slated for preservation were The Jungle (1967), a vivid portrayal of Philadelphia street life made by teen gang members; I'll Say He Forgot (1920), a long lost two-reel comedy about an absent-minded bridegroom; 6 films from the Youth Film Distribution Company, an organization that provided hands-on filmmaking experience for New York teens; and anthropologist Leopold Pospisil's 1950s documentary about a Papuan tribe in West New Guinea. The grants are open to American nonprofit and public organizations of all sizes and experience levels. Projects are selected by expert panels. Films preserved through NFPF grants are made available for education and shared with the public via screenings, exhibits, DVDs, broadcasts, and the web.

Repatriating American films unavailable in the U.S. The NFPF completed the New Zealand Film Archive Project preserving 176 long-unseen American films with support from Save America's Treasures, private donors, 5 studios, TCM, laboratories, and the Film Board. Announced and began partnership with the EYE Filmmuseum Netherlands to preserve and make available more than 50 American films that have been unseen for decades. Also completed was the online access component of Too Much Johnson (1938), created by Orson Welles for the Mercury Theatre. Thought destroyed, Too Much Johnson was unearthed in Italy by Cinemazero and preserved through a grant to George Eastman House.

Promoting film preservation through publications. The NFPF produces the award-winning Treasures DVD series presenting American films preserved by archives and previously unavailable on video. The sets are used in libraries and universities around the world. In 2014 the NFPF pressed ahead with Treasures 6: Next Wave Avant-Garde, surveying experimental filmmakers who rose to prominence after 1965. In addition, we continued to distribute our Film Preservation Guide (2004), which can be downloaded free or mailed on request. The award-winning primer has been translated into 3 languages. Our Field Guide to Sponsored Films (2006) is also distributed through these channels.
